# MINUTES OF A REGULAR MEETING OF THE MIDDLESEX COUNTY IMPROVEMENT AUTHORITY HELD ON WEDNESDAY, MAY 13, 2015 at 6:00 P.M. AT THE OFFICES OF THE AUTHORITY 101 INTERCHANCE PLAZA, CRANBURY (SOUTH BRUNSWICK), NEW JERSEY

Robert J. Mantz acted as Chairman of the meeting.

After the salute to the flag, the Chairman called the meeting to order. Ms. Venezia read the following statement: "This meeting today conforms with Chapter 231 P.L. 1975 called the 'Open Public Meeting Act' and as per the requirements of the statute, notification of the meeting was published in The Star Ledger and Home News Tribune and filed with the Clerk of Middlesex County."

The first item on the agenda was correspondence. Mr. Pucci stated that all reports and communications are contained in the member packages.

Upon motion duly made by Anthony Raczynski, seconded by Jacque Eaker and unanimously approved by the members present, the Financial Report was received and filed with the minutes.

Mr. Windas provided the Recycling Report. Mr. Windas stated that 1,707 tons of material was collected and recycled last month from the 14 towns participating in the Program. This is a slight decrease from last year and likely reflects the newness of the single stream recycling collection. Once the program becomes more familiar, it is expected that the tonnages will increase. Twelve new single family homes were added to the Program making the total number of units serviced 89,689. The municipalities participating in the Program are adopting the agreements. Under the yard waste program, 1,503 tons of material were recycled. The grass season has started. Mr. Windas stated that the bid specs have been issued for the yard waste recycling contract. The new contract will be for a two year period to commence on August 1, 2015 with a one year

option. Mr. Pucci asked Mr. Windas to report on the new curbside contract. Mr. Windas stated that most of the drivers for Central Jersey have come out of the Trenton area so it has been a learning curve. Phone calls concerning missed pick-ups have decreased substantially in the last two weeks. Mr. Windas stated that he is happy with the progress and commended the route supervisor.

Under the Golf Course Report, Mr. Pucci reported that the rounds of golf played are starting to come back from the bad winter weather. Rounds should pick up now.

Mr. Pannella provided the Financing Report. Mr. Pannella stated that the Capital Equipment Program sizing is on target and he will report back in June on the progress of the financing.

Upon motion duly made by Anthony Raczynski, seconded by Jacque Eaker and unanimously approved, the Economic Development report was received.

Mr. Pucci introduced Dave Wasenda of AppliedGolf to address the meeting. Mr. Wasenda is the President of AppliedGolf. He stated that his company oversees 17 golf courses and the company specializes in financial turn arounds for golf courses. Mr. Wasenda stated that municipal course play is getting more competitive. He has reviewed The Meadows and stated that out of County play may be a void that should be targeted. A program to increase the identification of The Meadows will be undertaken to make people aware of the course and where it is. Another marketing measure that will be undertaken is a targeting of twilight golfers. This effort will appeal to those who have time as a concern and will be a more affordable alternative for some golfers. These programs have been successful at other courses. Another suggestion is the pricing of golf carts on a per individual basis rather than per cart. This would yield more golf cart useage.

Mr. Wasenda introduced the newly designed website for The Meadows and stated that it will include all three of the County courses. Marketing handouts have been designed. Another important tool will be the use of Golfnow. Golfnow is owned by NBC Universal and has become something like an Expedia for golf courses. For the long term plan, Mr. Wasenda stated that the campaign will focus on branding the three courses and creating relationships with local organizations like the Middlesex County Chamber of Commerce. These measures require no investment by the Authority. After discussion, the members agreed that the initiatives should be undertaken.

There being no Old Business, the meeting proceeded to a discussion of New Business and the Resolutions. Resolution (a) approves an interlocal services agreement with the County of Middlesex for IT support. Resolution (b) authorizes the addition of a new depository, First Bank. Resolution (c) authorizes the transfer of a dump truck to the Middlesex County Utilities Authority. The truck is no longer needed for the recycling operations. Resolution (d) approves the sale of compost material and sets the rate for same. Mr. Windas stated that this will be the last year for the sale of compost material as the Quarry Lane site is no longer operating.

Resolution (e) approves an agreement with Middlesex County College for the training of students at the Roosevelt Care Center at Edison facility. Resolution (f) awards contracts for temporary nursing personnel at the Roosevelt Care Center facilities. The Authority undertook a competitive contracting process for the procurement of the services. The resolution accepts the recommendation of awards in accordance with the report. Resolution (g) authorizes a contract for wound care services at the Roosevelt Care Center facilities. The award of a contract for medical laboratory testing services to the sole bidder is authorized by Resolution (h). Resolution (i) authorizes a one year option on the ambulance transportation contract with Pulse. Mr. Pucci continued stating that Resolution (j) authorizes a contract for the procurement of pharmacy interface software and support for the Roosevelt Care Center facilities. Resolution (k) authorizes the procurement of goods from the State contracted vendor WB Mason.

Concerning golf course operations, Resolution (l) authorizes award of a contract for golf cart batteries to the lowest responsive bidder.

Resolution (m) authorizes a request to the EPA for an extension of the Brownfield grant for a period of one year as well as amendment to the work plan and budget modification.

Concerning the Open Space and Farmland Preservation Program, Resolutions (n) and (o) approve engineering and appraisal services, respectively.

The next item on the agenda was the approval of the minutes of the meeting of April 8, 2015. Upon motion duly made by Anthony Raczynski, seconded by Jacque Eaker, and unanimously approved by the members present, the minutes of the meeting of April 8, 2015 were approved.

The Chairman invited the public to comment on the resolutions. There being no response from the public, upon motion duly made by Anthony Raczynski, seconded by Jacque Eaker and unanimously approved by the members present, the members determined to consider the resolutions by consent and adopted the following resolutions:

## RESOLUTION OF THE MIDDLESEX COUNTY IMPROVEMENT AUTHORITY APPROVING INTERLOCAL SERVICES AGREEMENT WITH COUNTY FOR

**WHEREAS,** a regular meeting of the Middlesex County Improvement Authority (the "Authority") was held on May 13, 2015; and

IT SUPPORT AND ACTS IN CONNECTION THEREWITH

**WHEREAS**, pursuant to N.J.S.A. 40:37A-55(t) the Authority is authorized to enter into any and all agreements or contracts, execute any and all instruments, and do and perform any and all acts or things necessary, convenient or desirable for the purposes of the Authority; and

**WHEREAS,** the County of Middlesex (the "County") has certain staff that is well trained in information technology ("IT") and has the equipment and knowledge necessary to provide IT support; and

**WHEREAS,** the Authority has a need for IT support for its administrative systems, for the golf course operations, for the recycling operations and for the systems at the Roosevelt Care Center facilities; and

**WHEREAS,** pursuant to N.J.S.A. 40A:11-5(2), contracts made and entered into between any county and authority are not subject to the provisions of the Local Public Contracts Law; and

**WHEREAS,** pursuant to N.J.S.A. 40:8A-1 et seq., the Interlocal Services Act, the Authority and County may enter into an agreement for the provision of services by one of the parties; and

**WHEREAS,** the Authority would like to approve an agreement (the "Agreement") with the County for the provision of IT support and authorize the entering into and execution of the Agreement with the County in accordance with this Resolution.

## NOW, THEREFORE, IT IS HEREBY RESOLVED BY THE MEMBERS OF THE MIDDLESEX COUNTY IMPROVEMENT AUTHORITY AS FOLLOWS:

- 1. The Authority hereby approves the Agreement with the County in substantially the form attached with such changes as shall be approved by the Chairman on advice of counsel.
- 2. The Authority authorizes the Chairman or Vice-Chairman to execute the Agreement with the County on behalf of the Authority and the Secretary to attest to the signature of the Chairman or Vice-Chairman appearing thereon and to affix the seal of the Authority thereto.
- 3. The Authority authorizes the Executive Director to take any acts that may be required to be undertaken by the Authority in connection with the Agreement.
- 4. The Certifying Finance Officer has certified that the funds for the Agreement are available in the 2015 budget and will be included in the budgets for ensuing years.

**WHEREAS,** the Authority would like to approve the Program with Middlesex County College and authorize an agreement with Middlesex County College for the Program.

## NOW, THEREFORE, IT IS HEREBY RESOLVED BY THE MEMBERS OF THE MIDDLESEX COUNTY IMPROVEMENT AUTHORITY AS FOLLOWS:

- 1. The Authority hereby approves the Program with Middlesex County College.
- 2. The Authority authorizes the Chairman to approve an agreement (the "Agreement") with the College concerning the Program.
- 3. The Authority authorizes the Chairman or Vice-Chairman to execute and deliver the Agreement in the form so approved and authorizes the Secretary to attest to the signature of the Chairman or Vice-Chairman appearing thereon and to affix the seal of the Authority thereto.
- 4. The Authority hereby authorizes the Licensed Administrator of Roosevelt Care Center at Edison to take all acts reasonable and necessary in connection with implementation of the Program.

**WHEREAS,** the Authority requires the provision of temporary nursing personnel to supplement Authority staff when required (the "Services") for Roosevelt Care Center; and

**WHEREAS,** by Resolution 15-51 duly adopted by the Authority on March 11, 2015, the Authority authorized the undertaking of a competitive procurement process for the Services; and

**WHEREAS**, the Authority prepared and issued a Request for Proposals (RFP) for the Services and publicly advertised for proposals for the Services; and

WHEREAS, the Authority received proposals for the Services from All American Health Care Services, Inc., General Healthcare Resources, Inc., Horizon Healthcare Staffing Corp., Interim Healthcare Middlesex Somerset, Inc., Medical Staffing Services, Inc. and Mercury Professionals, LLC; and

**WHEREAS,** the Administrator of Roosevelt Care Center at Edison and Administrator of Roosevelt Care Center at Old Bridge have reviewed and evaluated the proposals; and

**WHEREAS**, the results of the evaluation have been compiled in a report and recommendation (the "Report") which is attached hereto and made a part hereof; and

**WHEREAS**, the Authority would like to accept the results of the Report and award contracts for the Services in accordance with Schedule A attached hereto.

NOW, THEREFORE, IT IS HEREBY RESOLVED BY THE MEMBERS OF THE MIDDLESEX COUNTY IMPROVEMENT AUTHORITY AS FOLLOWS:

1. The Authority accepts the Report and adopts the findings contained in the Report.

Services will be requested from each of the vendors for each of the categories of Services (Supervisors, RN, LPN or CNA) in the order set forth on Schedule A. The award of the contract to the proposers as set forth on Schedule A is contingent upon the provision of required insurance by the respective proposer.
- 3. The Authority authorizes the Chairman or Vice-Chairman to execute contracts with the proposers set forth on Schedule A in the form contained in the RFP. The Secretary is authorized to attest to the signature of the Chairman or Vice-Chairman appearing thereon and to affix the seal of the Authority thereto.
- 4. The Certifying Finance Officer has certified that the funds for the Services are available from and can be obtained from the funds of the Authority and will be included in future year budgets.
- 5. The Secretary is authorized to cause a notice to be published summarizing the award of the contracts in accordance with N.J.S.A. 40A:11-4.5.

**WHEREAS**, the Certifying Finance Officer has determined and certified that the value of the contract will not exceed \$17,500.00; and

**WHEREAS**, the Authority would like to authorize a contract with Advantage Wound Care for the provision of the Services in accordance with this Resolution.
